**ORDER**

The Director of Public Instruction, in his proceedings order read as 1st paper above had transferred and posted the Lecturers of DIET in various DIETs in the State. Aggrieved by this order 11 incumbents filed WP(C) before the Hon'ble High Court as detailed below.

Hon'ble High Court vide common order read as 2<sup>nd</sup> paper above have directed the Government that the petitioners will file the appeals within a period of one week from the date of judgement and all the appeals will be disposed of by the Government within a period of one month. As such petitioners filed appeals before the Government and they were heard by the Secretary, General Education on 7.10.2011.

On going through the cases in the hearing it was understood that all of them have completed more than three years and hence they are fit to be transferred. Petitioners in Idukki and Wayanad have pointed out that they face shortage of DIET staff in all faculties. Generally DIET lecturers are posted against their respective faculties and faculty change is not allowed. Similarly interchange of Senior Lecturer and lecturer is not allowable.

In the instant case the only grievance raised is that transfers have been effected in September half way through the academic year, have adversely affected the petitioners. After considering the grievance, arguments and requests, Government decided to revise the proceedings of the Director of Public Instruction. Hence Government are pleased to direct that the DPI should revise proceedings order read as 1<sup>st</sup> paper above after examining the possibility to accommodate these employees in the following manner as a special case with condition that the shortage of teaching staff in DIET Idukki and Wayanad should be addressed. At the same time Sri. Prasad.N. and Sri. N. Gopalakrishna Pillai working in Kollam and Pathanamthitta also have requested to be retained in the respective places.

The arrangements ordered above are purely temporary in nature considering the special aspects of the issue and cease w.e.f. the end of the current academic year. This will not be treated as precedent for claiming posts in other faculties to avoid transfer.

As such the Court direction has been complied with and the appeals disposed of.
